2023 SALARY ORDINANCE

BE IT ORDAINED by the County of Porter that for the expense of salaries and wages for the County and its institutions for the year ending December 31, 2023, the following sums of money are hereby ordered set apart out of the funds herein named, subject to the laws governing the same.

The Porter County Salary and Wage Ordinance (the “ordinance”) sets the annual compensation amounts and hourly rates as adopted by the Porter County Council for all positions in each department. This ordinance identifies the amounts paid from each county fund from which employees are compensated.

When filling vacant positions, Porter County department heads may determine that a position warrants lower compensation than adopted by ordinance. The Porter County Council grants department heads the authority to fill vacant positions up to, but not exceeding, the stated pay level without first receiving Council approval, provided that:

1. Department heads notify the Porter County Auditor’s Office that they are exercising their option to fill a vacant position at a lower pay level by submitting an Employee Status Change form that includes a proposed Form 144 with the reduced compensation.
2. Department heads follow existing policy by filling new positions only at the start of a new pay period and by submitting the Employee Status Change form in compliance with deadlines enacted by the Auditor’s Office.
3. Department heads submit their proposed Form 144 to the Porter County Council’s office for consideration at the next available meeting.
4. In the event the council rejects the revision, the originally adopted pay level will apply, effective with the next available pay period, unless the council sets the salary at an alternate amount.

2023 Supplemental Pay

Certain full-time employees and elected officials will receive a supplemental pay of up to \$4,000 in budget year 2023. The supplemental pay plus any raise granted for 2023 shall not exceed 20% of the previous year's salary, unless certain exceptions were granted by the County Council. The supplemental pay will be granted to employees who were employed full-time by Porter County Government as of December 31, 2022 and who remained employed full-time by Porter County Government as of the pay period for which the supplemental pay is awarded. The supplemental pay will be distributed by February 17, 2023. The Porter County Council will make the final determination in the event of disputes as to the eligibility of employees, and any other related matter.

The following elected officials will receive supplemental pay of up to \$4,000 in addition to the compensation amounts listed in this ordinance in 2023: County Assessor, County Clerk, County Commissioners, County Council, Portage Township Assessor, and County Treasurer.
